





STEPS OF IMPORT AND ROLE OF SOEX







- 3. Quality control** over the equipment manufacturing, participation in testing (including certification tests) in order to prepare the equipment for the compliance assessment
- 4. Consulting** manufacturer or supplier during the operational documentation preparation in accordance of the Russian law (regulations)
- 5. Evaluation** of the compliance assessment (including previous tests and operational documentation) of the manufactured equipment (declaration, certification and industrial safety assessment).


- Pre-installation technical diagnostic of the equipment

- Primary testing of the equipment for the durability (strength) and density
- Industrial safety assessment report including expert's assessment and registration in executive authorities

7. Participation in commissioning and development of regime cards

8. Preparation of a final set of documents, delivery of documents to the customer

9. Consulting of the customer in obtaining permission to input of the equipment in operation
